1. Scope, Application, & Purpose.

This Privacy Policy was last revised on March 13, 2019, and is effective as of that date. This Privacy Policy reflects the commitment of R+K Wellness MD, LLC, to protect the security of information we obtain about you on our website, and informs how R+K Wellness MD, LLC, a Colorado Limited Liability Company, uses and shares the personal information of users of its website. We may provide more information regarding information collection or use in connection with additional products, services, or portions of our website. By using the website of R+K Wellness MD, LLC, you agree to the collection, use, and storage of your information as contemplated in this Privacy Policy.

2. Information Collected, Use, & Storage.

Most of the information we collect about you comes directly from you. R+K Wellness MD, LLC, collects & uses information about you in the following ways:

- Access to this Website. When you use our website, we may collect information required to operate the website, comply with applicable laws or regulations.
 - Why we do this: At times, it may be necessary to collect information to comply with applicable laws. We also strive to provide the best website user experience we can. This can involve collecting information to enhance website user experience, such as through preferences you select.
- Responding to you. Our website allows you to contact us. When you use any function on our website that allows you to reach out to R+K Wellness MD, LLC, we store your contact information, alongside any other information you volunteer. Most commonly, information you volunteer is that embodied in the body of your submission.

 - Why we do this: Communicating with you about your care helps us continually ensure that our opinions regarding recommendations are right for you.
- General Audience. This website, our services, and all other features related to R+K Wellness MD, LLC, are intended for a general audience and NOT any individual under the age of 21. By using our website you represent and warrant that you are at least 21 years of age. - On-site visitors. When you come into our offices, information about you may be collected.
